References are made to the announcement of the Company dated 28 July 2022 on discloseable transaction in relation to finance lease arrangement and exempt connected transactions in relation to guarantees and share pledges, the announcement of the Company dated 22 April 2022 on discloseable transaction in relation to finance lease arrangement and exempt connected transactions in relation to guarantees and share pledges, and the announcement of the Company dated 28 January 2022 on discloseable transaction in relation to sale and leaseback arrangement and exempt connected transactions in relation to guarantees and share pledges (the “**2022 Announcements**”). Unless otherwise specified, capitalised terms used herein shall have the same meaning as those defined in the 2022 Announcements.

The Board is pleased to announce that further on 11 January 2023 (after trading hours):

**SALE AND LEASEBACK ARRANGEMENT (JANUARY 2023)**

- (a) Guizhou Puxin (an indirect wholly-owned subsidiary of the Company) and Xinsong Coal (an indirect wholly-owned subsidiary of the Company), and CCTEG entered into the Sale and Leaseback Agreement (January 2023) for (i) the sale of the Relevant Coal Machinery and Equipment (January 2023) to CCTEG for an aggregate consideration of CNY30,000,000 (equivalent to approximately HK\$34,647,000) and (ii) the leaseback of the Relevant Coal Machinery and Equipment (January 2023) from CCTEG for an aggregate consideration of CNY33,140,439 (equivalent to approximately HK\$38,273,893);
- (b) Xinsong Coal and CCTEG entered into the Consultancy Agreement (January 2023), pursuant to which Xinsong Coal agreed to engage CCTEG for providing certain consultancy services relating to the Sale and Leaseback Arrangement (January 2023) for a service fee of CNY1,350,000 (equivalent to approximately HK\$1,559,115).

On the same date, the Pledge Agreement (January 2023) was executed by Xinsong Coal, the Share Pledge Agreements (January 2023) were executed by Guizhou Puxin and Yangpu Dashi, and the Corporate Guarantee (January 2023) and the Personal Guarantee (January 2023) were executed by Mr. Li and certain associates of him in favour of CCTEG to secure the performance obligations (including among others, payment obligations) owed by the Relevant Group Companies IV to CCTEG under the Sale and Leaseback Agreement (January 2023).

### **IMPLICATIONS UNDER THE LISTING RULES**

Pursuant to Rules 14.22 and 14.23(1) of the Listing Rules, the Sale and Leaseback Arrangement (January 2023), and the Finance Lease Arrangement (July 2022), the Finance Lease Arrangement (April 2022) and the Sale and Leaseback Arrangement (January 2022) entered in 2022 as disclosed in the 2022 Announcements are aggregated. As one or more of the applicable percentage ratios in respect of the Sale and Leaseback Arrangement (January 2023), the Finance Lease Arrangement (July 2022), the Finance Lease Arrangement (April 2022) and the Sale and Leaseback Arrangement (January 2022), when aggregated, exceed 5% but are less than 25%, the Sale and Leaseback Arrangement (January 2023), together with the Finance Lease Arrangement (July 2022), the Finance Lease Arrangement (April 2022) and the Sale and Leaseback Arrangement (January 2022) entered in 2022, constitutes a discloseable transaction of the Company under the Listing Rules and is therefore subject to the notification and announcement requirements but exempt from the shareholders' approval requirement under Chapter 14 of the Listing Rules.

Mr. Li, being the controlling shareholder of the Company, is a connected person of the Company under Chapter 14A of the Listing Rules. Given that Feishang Enterprise and Ms. Wang are both associates of Mr. Li, the provisions of the Corporate Guarantee (January 2023) and the Personal Guarantee (January 2023) for the benefit of the Relevant Group Companies IV amount to financial assistance by Mr. Li for the benefit of the Group. As such financial assistance (i) is provided on normal commercial terms or better to the Group; and (ii) is not secured by the assets of the Group, the Corporate Guarantee (January 2023) and the Personal Guarantee (January 2023) are both considered as exempt connected transactions pursuant to Rule 14A.90 of the Listing Rules, which are fully exempted from the reporting, announcement and independent shareholders' approval requirements under Chapter 14A of the Listing Rules.

### Sale and Leaseback Agreement (January 2023)

#### A. Sale

The principal terms relating to the sale under the Sale and Leaseback Agreement (January 2023) are set out below:

<b>Sale consideration and payment terms</b>	:	The aggregate consideration payable by the Purchaser to the Sellers for the sale of Relevant Coal Machinery and Equipment (January 2023) is CNY30,000,000 (equivalent to approximately HK\$34,647,000), which shall be paid in cash upon fulfilling certain conditions.
<b>Ownership of the Relevant Coal Machinery and Equipment (January 2023)</b>	:	During the Lease Period (January 2023), CCTEG will have legal ownership of the Relevant Coal Machinery and Equipment (January 2023).

<b>Consideration and payment terms</b>	:	The service fee payable by Xinsong Coal to CCTEG for the provision of certain consultancy services relating to the Sale and Leaseback Arrangement (January 2023) by CCTEG is CNY1,350,000 (equivalent to approximately HK\$1,559,115), which shall be settled in cash on an agreed date.

The service fee was determined after arm's length negotiation between the parties.

### **2. PLEDGE AGREEMENT (JANUARY 2023), SHARE PLEDGE AGREEMENTS (JANUARY 2023), CORPORATE GUARANTEE (JANUARY 2023) AND PERSONAL GUARANTEE (JANUARY 2023)**

Pursuant to the Sale and Leaseback Agreement (January 2023), the Pledge Agreement (January 2023) was executed by Xinsong Coal, the Share Pledge Agreements (January 2023) were executed by Guizhou Puxin and Yangpu Dashi, and the Corporate Guarantee (January 2023) and the Personal Guarantee (January 2023) were executed by Mr. Li and certain associates of him in favour of CCTEG to secure the performance obligations (including among others, payment obligations) owed by the Relevant Group Companies IV to CCTEG.

#### **2.1 Pledge Agreement (January 2023)**

On 11 January 2023, Xinsong Coal entered into the Pledge Agreement (January 2023), pursuant to which Xinsong Coal agreed to pledge the Relevant Coal Machinery and Equipment (January 2023) to secure the performance obligations (including among others, payment obligations) of Guizhou Puxin and Xinsong Coal to CCTEG under the Sale and Leaseback Agreement (January 2023).

## **2.2 Share Pledge Agreements (January 2023)**

On 11 January 2023, Guizhou Puxin and Yangpu Dashi entered into a series of Share Pledge Agreements (January 2023) with CCTEG, pursuant to which Guizhou Puxin agreed to pledge its equity interests in Guizhou Dayun, Guizhou Yongfu, Baiping Mining and Xinsong Coal, representing 50%, 70%, 70% and 100% of the equity interests in Guizhou Dayun, Guizhou Yongfu, Baiping Mining and Xinsong Coal, respectively, and Yangpu Dashi agreed to pledge its equity interests in Guizhou Dayun, representing 50% of the equity interests in Guizhou Dayun, in favour of CCTEG to secure the performance obligations (including, among others, payment obligations) of Guizhou Puxin and its subsidiaries to CCTEG under the Sale and Leaseback Agreement (January 2023) and other existing and potential financial leasing arrangements.

## **2.3 Corporate Guarantee (January 2023)**

On 11 January 2023, Feishang Enterprise executed the Corporate Guarantee (January 2023) with CCTEG, pursuant to which Feishang Enterprise agreed to provide guarantee in favour of CCTEG to secure the performance obligations (including, among others, payment obligations) of Guizhou Puxin and Xinsong Coal to CCTEG under the Sale and Leaseback Agreement (January 2023).

## **2.4 Personal Guarantee (January 2023)**

On 11 January 2023, Mr. Li and Ms. Wang (the spouse of Mr. Li) executed the Personal Guarantee (January 2023) with CCTEG, pursuant to which Mr. Li and Ms. Wang agreed to provide guarantee in favour of CCTEG to secure the performance obligations (including, among others, payment obligations) of Guizhou Puxin and Xinsong Coal to CCTEG under the Sale and Leaseback Agreement (January 2023).

## **3. REASONS FOR AND BENEFITS OF ENTERING INTO THE SALE AND LEASEBACK ARRANGEMENT (JANUARY 2023)**

The Directors are of the view that the entering into of the Sale and Leaseback Arrangement (January 2023) will enhance the working capital positions of the Relevant Group Companies IV and allow them to optimise their asset and debt structures by increasing the percentage of long-term financing and to support their business and operational activities.

The Directors consider that the Sale and Leaseback Arrangement (January 2023) was entered into on normal commercial terms after arm's length negotiation between the parties and the terms of the Sale and Leaseback Arrangement (January 2023) are fair and reasonable and are in the interest of the Company and its shareholders as a whole.

## **4. INFORMATION ON THE PARTIES TO THE SALE AND LEASEBACK ARRANGEMENT (JANUARY 2023)**

### **4.1 The Group**

The Group is based in Guizhou province of the PRC and is mainly engaged in the acquisition, construction and development of anthracite coal mines and the extraction and sale of anthracite coal in the PRC. As at the date of this announcement, the Group's mining assets consist of four underground anthracite coal mines in Guizhou province, the PRC. Please refer to the 2021 annual report of the Company for more details of the Group's mining assets.

### **4.2 Guizhou Puxin**

Guizhou Puxin is an indirect wholly-owned subsidiary of the Company and is engaged in investment holding and coal trading. It holds the mining rights to four anthracite coal mines.

### **4.3 Xinsong Coal**

Xinsong Coal is an indirect wholly-owned subsidiary of the Company and is principally engaged in coal development and mining.

### **4.4 CCTEG**

CCTEG provides financial leasing services as well as other financial services to various industries and institutions in the PRC.

To the best of the Directors' knowledge, information and belief having made all reasonable enquiries, CCTEG is majority owned by (i) state-owned enterprises of the PRC, namely, China Coal Technology & Engineering Group Corporation\* (中國煤炭科工集團有限公司) and China Chengtong Holdings Group Ltd.\* (中國誠通控股集團有限公司), and (ii) a local government entity, namely, Tianjin Dongjiang Bonded Port Area Administration Commission\* (天津東疆保稅港區管理委員會). The ultimate beneficial owner of the above mentioned two state-owned enterprises is the State-owned Assets Supervision and Administration Commission of the State Council\* (國務院國有資產監督管理委員會) of the PRC. They are all Independent Third Parties.
